March 12, 2021

A video conferencing meeting of the Vermont Economic Development Authority's Loan Committee convened on March 12, 2021 beginning at 9:03 a.m. Those Committee Members present via video conferencing were: T. ## Minutes of December 18, 2020

On a motion by M. Tuttle, seconded by T. Foster, the minutes for the December 18, 2020 Loan Committee Meeting were approved by those Members of the Committee present by a vote of 8 to 0 with the Chair abstaining.

#### Mansfield Community Fiber, Inc. - Cambridge - BBLP - \$2,077,000

S. Buckley explained Mansfield Community Fiber, Inc. (MCF) of Cambridge is requesting a \$2,077,000 Broadband Expansion Loan. The loan will be secured by a security interest in all Borrower's business assets and collateral assignment of all necessary contracts and lease agreements necessary for MCF to conduct business. The loan will also be personally guaranteed by the majority owners of MCF and the guarantees will by secured by mortgages on personal real estate located at 84 Bolger Hill Road and 26 Morgan Road in Jericho, Vermont.

After discussion regarding interest rate, risk-based capital, and program parameters, on a motion by L. Graves, seconded by E. Delhagen, the loan was approved by those Members of the Committee present by a vote of 7 to 1 with B. Pearce opposed and the Chair abstaining.
