#### Minutes

4. Staff Authority – Other Business

On a motion by T. Foster, seconded by T. Collier, the consent agenda was approved as presented by those Directors of the Corporation present by a vote of 11 to 0 with the Chair abstaining.

## Agricultural Update

A. Eastman noted the Working Lands Enterprise Board has made decisions regarding grants with money going into slaughterhouse facilities to help with the congestion in that sector exacerbated by COVID. She noted there will also be producer grants.

She continued, noting her own work in the private sector working with immigrant workers, including Bridges to Health through UVM Extension, and the importance of these programs. A. Eastman then remarked on an upcoming webinar to be hosted by A. Tebbetts, Secretary of the Agency of Agriculture, Food and Markets (the Agency) and L. Kurrle, Secretary of the Agency of Commerce and Community Development. She explained the webinar will include a discussion of VISA programs to bring migrants to Vermont to work including H-2A, H-2B and J-1.

A. Eastman continued her update by explaining a concern known to the Agency. The concern is regarding the failure to depackage items prior to being placed into an anaerobic digester. These packages include bread bags, fruit stickers, etc. – she noted the Agency is currently working through this situation.

A. Eastman continued her update with a discussion regarding the importance of mental health, noting this was an important topic in agriculture before COVID and is even more important now. She explained the Agency has an open position for a health care person – someone to meet some of the mental health needs in the agricultural industry. This person will work with the Agency, farmers and Farm Credit East.

Lastly, A. Eastman discussed the Inclusion, Diversity, Equity and Action (IDEA) Group and noted the Agency has submitted an RFP to find a contractor to build upon this work done internally at the Agency.

T. Foster then commented on milk pricing, noting grain prices are going up and fertilizer cannot be obtained. These two factors combined should shrink production, causing prices to increase.
