June 9, 2023

A meeting of the Vermont Economic Development Authority's Loan Committee convened on June 9, 2023 beginning at 9:02 a.m. Those Committee Members present via teleconferencing: S. Voigt, Chair; C. Minutes of April 14, 2023

On a motion by T. Gallagher, seconded by C. Carpenter, the Minutes of the April 14, 2023 Loan Committee Meeting were approved by those Members of the Committee present by a vote of 6 to 0 with the Chair abstaining.

Loan Presentation:

Sunrise Orchards, Inc. and James B. III and Christiana E. Hodges – Cornwall – Operating Loan (VACC) – \$130,000

A. Wood presented a request from Sunrise Orchards, Inc. and James B. III and Christiana E. Hodges for a \$130,000 Operating Loan to partially finance the construction of a cidery facility in Cornwall, Vermont, purchase cidery equipment and pay closing cost and fees. The loan will be secured by a security interest in all the Borrower's machinery and equipment and all insurance proceeds thereof.

After discussion regarding succession plans, management capabilities, farm designation with Agency of Agriculture, and the long relationship with VEDA/VACC, on a motion by C. Loan Presentation:

Dale R. Aines – Tinmouth – Farm Ownership Loan (VACC) – \$773,000


E. Howrigan presented a request from Dale R. Aines for a \$773,000 Farm Ownership Loan to purchase 192+/- acres of real estate and buildings, known as the Myer Farm, located in Tinmouth, Vermont. The loan will be secured by a mortgage on the subject real estate, mortgage lien on 1150+/- acres in Tinmouth, mortgage lien on 107+/- acres in Rupert and a shared lien on machinery and equipment.

After discussion regarding a Vermont Land Trust easement, business relationships for the bulk sale of organic syrup, and sugaring fuel source, on a motion by T. Gallagher, seconded by T. Foster, the Farm Ownership Loan request was approved by those Members of the Committee present by a vote of 7 to 0 with the Chair abstaining.

There being no other business to properly come before the Committee, on a motion by T. Gallagher, seconded by E. Delhagen, the meeting was adjourned at 9:29 a.m.
