E. Howrigan explained Dale R. Aines of Pawlet is requesting renewal of a \$60,000 line of credit for an additional five years. The line of credit is used for seasonal working capital needs and is secured by land, machinery, and equipment.

C. Leonard explained Iroquois Acres NWA, LLC; Ouellette, Steven, J. and Sherry; Ouellette, ; Pope, Seth J. and Pope, Stephanie J. are requesting a \$150,000 increase to their \$100,000 line of credit to be used for operating expenses in anticipation of potential higher input costs. The line of credit is secured by cattle, machinery and equipment, and a security interest in Borrower's milk and all products and proceeds thereof.

After discussion regarding management skills and collateral analysis, on a motion by T. Foster, seconded by T. Gallagher, the above line of credit was approved by those Members of the Committee present by a vote of 8 to 0 with the Chair abstaining.
