Loan Presentation:

Iroquois Acres NWA, LLC; Stephanie J. and Seth H. Pope and Steven J. and Sherry D. Ouellette

- Bridport - VACC Operation Loan - \$150,000

C. Leonard presented a \$150,000 Operating Loan request for Iroquois Acres NWA, LLC

and its Members Steven J. and Sherry D. Ouellette, and Stephanie J. and Seth H. Pope. The

Operating Loan request is to pay down VACC's line of credit which was used for the purchase of

41 mature Holstein cows and for the purchase of a dump truck. The loan will be secured by a

shared security interest in all of the Borrower's cattle, machinery and equipment, a security

interest in Borrower's milk and all products and proceeds thereof, and a first priority lien on the

dump truck. The loan is not SSBCI eligible. On a motion by M. Pieciak, seconded by

J. Goldstein, the Iroquois Acres NWA, LLC loan request was approved by those Members of the

Committee present by a vote of 7 to 0 with the Chair abstaining.

Other Business

C. Polhemus discussed the upcoming in-person July board meeting and the plans to have

a photographer on-site for board photographs.

Next, C. Polhemus indicated the Vermont legislative session has adjourned and that there

was no direct impact to VEDA. The VACC Statute, as part of the ag housekeeping bill S.301,

was approved by the Senate and is awaiting the Governor's signature. The new statute will be

effective July 1, 2024.
