Introductions

Minutes of March 9, 2021

On a motion by T. Collier, seconded by J. Goldstein, the minutes of the March 9, 2021 meeting were approved unanimously by those Members participating.

EV Charging Holdings LLC – Brattleboro – \$88,726

M. Corbett explained that the EV Charging Holdings LLC and another entity To Be Determined are requesting \$88,726 in SIB funding as part of a \$118,301 Project to purchase and install 3 electric vehicle charging stations at 580 Canal Street in Brattleboro, Vermont.

After discussion of per charge cost, ability to charge for charging, potential pairing of charging with solar panels on future projects, the principals, ongoing marketing of SIB, and the potential impact of recently passed federal legislation on SIB funding, a motion to approve the loan as presented was made by T. Collier, seconded by A. Flory.

On a vote of the Members present, the motion was approved unanimously, and the loan was approved.
